

## SFC Randall Shughart Memorial 5-Mile Run

presented by Cumberland Ag Expo





**When:** Saturday, August 4, 2018. Race starts at 9:00 am. Registration and Packet pickup 7:30 – 8:30 am at the starting line.

Where: Newville trailhead, Cumberland Valley Rails-to-Trails in Newville, PA

**Course:** Out-and-back on flat, fast crushed limestone surface of the Cumberland Valley Rail Trail, starting and finishing at Newville trailhead. See www.facebook.com/cumberlandagexpo for complete race-day details. Please park at the trailhead this year.

**Details:** \$30 prior to July 10th. Register online at <a href="www.cvraceseries.us">www.cvraceseries.us</a>. Look under upcoming events. Includes short sleeve tech shirt, if received by July 10th. After July 10, entry fee increases to \$35, but no shirt to allow production and shipping for race day. Race Day registration is \$35.

**Awards:** Presented to the top 3 males and top 3 females (under 40), plus top masters (40-plus) male and female. No duplication of awards. Awards and prizes immediately following finish at the trailhead. Students who cannot accept a cash prize per NCAA eligibility guidelines may decline cash awards.

**What else:** Two water stations along course route (out and back). A post-race assortment of sports drink, water, fruits and other goodies will be available. Complete results and photos will be posted online at <a href="https://www.cvraceseries.us">www.cvraceseries.us</a> following the race.

**Directions:** Exit 37 off Interstate 81. Take Route 233 North for 3.8 miles. Turn left onto Vine Street/Route 533. Drive 1 mile, turn left on Cherry St OR Rich St to trailhead parking lot.
